## **F.A.Q Sheet for ENCLEAN®**

### **What is Enclean?**

Enclean is a biocide with curative, algacide effects on outdoor buildings and building materials, on all hard surfaces, (porous & non-porous) in green spaces, and every roof type except thatched.

### **What is the active ingredient in Enclean?**

Enclean is an emulsifiable concentrate formulation (EC) containing 500g/L (51.92%w/w) nonanoic acid

### **How would I use Enclean?**

Enclean can be applied through a knapsack sprayer as well as a walk behind/vehicle mounted boom sprayer when appropriate for the the surface to be treated.

### **What are the PPE requirements for using Enclean?**

Follow the current label for full guidance on PPE, and always follow your companies best practice instructions. Carry out a COSHH assessment before using the product.

### **How much Enclean to use in a knapsack sprayer?**

Use 1 litre of Enclean within 15 litres of water, this should cover 550m<sup>2</sup>

### **What Nozzle should be used to apply Enclean?**

Use a Red 04 ES Falt Fan nozzle on your knapsack

### **Should I use a shield on my spray lance when using Enclean?**

It can be useful to use a shield to reduce drift onto non-target organisms or plants

### **Will Enclean damage my knapsack sprayer, especially over a seasons use?**

Provided the sprayer is cleaned after use then the knapsack should function throughout the season. Never leave any solution overnight in a knapsack as activity of the product maybe affected.

### **How long can I store Enclean for?**

The storage period for Enclean is 2 years

### **What size container can I buy Enclean in?**

Enclean is only available in 1 litre containers

### **Why would I use Enclean?**

Enclean is easy to use, cost effective and provides long term control where it has been applied

### **How safe is Enclean in the environment?**

Enclean has a good environmental profile, full details can be found in the latest Environmental Information Sheet (EIS) leaflet for the product on the Belchim website

### **Where can I use Enclean?**

Enclean can be used on all hard surfaces, both porous and non-porous, eg. Paving, walls, fencing, and roofs, (not thatched), by professional users.

### **Are there any surfaces that I cant use Enclean on?**

Yes, Thatched roofing, and Copper & Lead surfaces which could be oxidised by the product

### **Will Enclean leave a stain or residue?**

Enclean will not stain, however on some surfaces a white residue can be visible, this should be washed off if still present after 10-14 days

### **Do I have to be careful if there is rain forecast?**

Enclean is generally rain fast within 2 hours, but it is better to use the product when rain is not forecast on the day of application.

### **How long will Enclean keep a surface clean from algae?**

This depends on the time of year and what conditions were experienced at the time of application, the effects of Enclean should be seen for at least a month or longer

### **How many times a year can I use Enclean?**

Enclean can be used 2 times per year

### **Will Enclean kill weeds too?**

Enclean is a biocide and should be used as per label recommendations

### **Is Enclean the same as Katoun Gold?**

Enclean is a biocide whereas Katoun Gold is registered as a herbicide
